Per installatore: Al fine di garantire la durata del prodotto installare rubinetti con filtro da pulire periodicamente. Effettuare risciacquo delle tubazioni prima di installare il prodotto (PUNTO 1) Eventuali residui se finissero all'interno della cartuccia potrebbero causarne il danneggiamento
For installer: In order to guarantee a long duration of the product install valves with filter, which have to be regularly cleaned (POINT 1). Carry out the rinsing of the pipes before install the tap. Some external materials may damage the cartridge if not removed before the installation.




MANUTENZIONE E PULIZIA




MAINTENANCE AND CLEANING

For a proper maintenance and cleaning, we recommend the following:

- **Rinse** with water and **always dry** with a clean cloth to avoid residue of detergent
- Perform a **periodic cleaning** to prevent limestone deposits















 **SOSTITUZIONE CARTUCCIA / CARTRIDGE REPLACEMENT**
